The City of Dublin is now accepting nominations for the 2014 Citizen of the Year, Young Citizen of the Year and Organization of the Year. The purpose of these awards is to recognize outstanding individuals and groups who have contributed to the quality of life in Dublin in 2014.

Nominations are based on five established criteria: the Dublin Pride – Integrity in Action Program's ten characteristics: (i.e. Responsibility, Respectfulness, Caring, Giving, Positive Attitude, Trustworthiness, Cooperation, Doing One's Best, Honesty and Self Discipline); originality and uniqueness of the activity/project; overall relevance and importance to the Dublin community; time and effort spent; and challenge(s) in accomplishing the activity/project.

Nominees will be recognized at the Volunteer Recognition Event on Wednesday, February 19, 2015 at the Shannon Community Center. Organization of the Year will receive \$500 cash prize and \$300 donation will be given to each of the Citizen and Young Citizen of the Year's favorite non-profit organization.
